Sec. 1. That: Town Officers or employees in order to further their knowledge of Town Government in the performance of their duties may attend meetings with consent of the Town Board, including the Annual Association of Towns Meeting, and be compensated for the ordinary expenses of travel, meals, and lodging. Vouchers must be submitted for all out of pocket expenses including meals. Cost to be approved by the Town Board and paid out of their respective budgets.

### No. 8. Special Districts:

Sec. 1. That: The Town Board, as Commissioners of the Town's Special Districts, pursuant to Section 29-16 of the Town Law, does hereby designate the Supervisor to perform the duties of administration and supervision for all Special Districts on behalf of said Board.

### No. 9. Special Funds:

Sec. 1. That: Pursuant to Town Law Section 64(a), the Town Board establishes and approves the following Petty Cash Funds, not to exceed:

\$150.00, to be maintained and disbursed by the Town Clerk; \$200.00, to be maintained and disbursed by the Tax Collector; \$75.00, to be maintained and disbursed by the Court Clerk; \$20.00, to be maintained and disbursed by the Historian;

\$50.00, to be maintained and disbursed by the Nutrition Center;

\$100.00, to be maintained and disbursed by the Recreation Commission.

#### No. 10. Superintendent of Public Works:

Sec. 1. That: Pursuant to Chapter 77 of the Town of Wheatland Code, the Town Board hereby appoints Howard Hazelton as Superintendent of Public Works, as defined in said Chapter, to oversee the Northeast Sanitary Sewer District.

Sec. 2. That: The Wheatland Town Board hereby appoints Howard Hazelton as Director of Parks for the Town of Wheatland.

#### No. 11. Small Tool Purchases:

Sec. 1. That: Pursuant to Section 142-1a of the Highway Law, the Highway Superintendent is authorized to purchase tools and equipment without prior approval of the Town Board in amounts not to exceed \$2,000.00, and not to exceed the budget.

#### No. 12. Mileage Reimbursement:

Sec. 1. That: Pursuant to 102-1 of the Town Law, mileage allowance of 0.58 cents per mile is to be paid to Town officers and employees for use of private autos while on official Town business. All claims shall be itemized on an approved town form and audited. Claims will be approved, or paid, within 30 days of the end of the fiscal year.

### No. 13. Policies and Benefits of Wheatland Employees:

Sec. 1. That: The Town Board of the Town of Wheatland approves all rules, regulations and benefits set forth in the document entitled "TOWN OF WHEATLAND EMPLOYEE HANDBOOK" adopted by Resolution of the Wheatland Town Board on November 16, 2017, including any adopted changes since that date.

#### No. 14. Fee Schedule for the Town of Wheatland:

Sec. 1. That: The Wheatland Town Board adopts the fee schedule currently held in the Building Department and Town Clerk's Office. Town Board will make changes by Resolution when appropriate.

### No. 15. Town Engineers:

Sec. 1. That: The Town of Wheatland will retain engineers when projects require these services.

### No. 16. Policy for Appointive Board Stipends:

Sec. 1. That: Stipends will be paid annually at the end of the fiscal year to each appointive board member according to the following schedule and eligibility criteria:

Chair- \$80.00 annually for serving on board Member- \$50.00 annually for serving on board

#### Planning Board:

Chair- \$80.00 per meeting for serving on board Member- \$50.00 per meeting for serving on board

#### **Zoning Board**:

Chair- \$80.00 per meeting for serving on board Member- \$50.00 per meeting for serving on board

#### Sec. 2. Criteria for Planning and Zoning Boards:

- 1. Attend 80% of scheduled meetings.
- 2. Board Members will only be paid for one board per night.
- 3. All first-year members are required to attend County/State training programs relating to board membership. Training program to be approved prior to attendance by Town Board.
- 4. All board members are required to participate annually in an approved inservice training course relating to board membership.
- 5. Internet instructional material relating to board membership may be used to fulfill the in-service training requirement. All internet material must be approved by both the chair and the Town Board prior to the end of March of the current year. Board member must submit written summary of the material upon completion.
- 6. All requirements need to be completed by the 15<sup>th</sup> of December of the current year. Vouchers must be submitted in time for the second abstract of December. Vouchers not submitted for the second abstract will not be paid, and money forfeited.

Supervisor Dobson opened the Public Hearing at 7:02 P.M.

# Local Law No. 2

Local Law No. 2 of 2019-Chapter 43 ANIMALS Article II Regulation and Control of Animal.

Terry Rech, Building Inspector said this was a Type I SEQR and a Notice of Intent to be lead agent was distributed.

The Building Inspector commented that this local law is an amendment that adds definitions and clarifies some areas that have been encountered over the years regarding animals and chickens, with chickens being the primary concern. There has been some desire by residents to have chickens and this has been discussed with the Planning Board. The Planning Board is comfortable with the proposed code revision but if it is the Town Board's desire, it can be removed.

Councilmembers have expressed concerns regarding Section 43-22, Domesticated chickens.

Attorney DiRaddo questioned, if Section 43-22 was removed, would the Town Code allow chickens. The Building Inspector responded that instead of having its own section and being permitted in some larger lot parcels in more dense residential zoning districts, it would fall

under farm animals and only in the AR-2 district with 2 acres or more. In the circumstance that it is more than 2 acres there would not be a limit on the number of chickens or roosters.

Attorney DiRaddo questioned, if Section 43-22 was removed would the code still control setbacks for structures housing the chickens in an AR-2 zone. The Building Inspector responded that it is addressed in the code.

Attorney DiRaddo brought up another concern of the Councilmembers in thinking about the the houses in the Hamlet of Mumford in comparison to areas outside of the Hamlet. The Building Inspector responded that most of Mumford is zoned with the smaller parcel zoning districts such as R-16 and R-12. If section 43-22 was removed, then the farm animals would be prohibited in those districts.

Attorney DiRaddo questioned whether there was anything in the code which addresses the issue of the waste product infiltrating the water stream. The Building Inspector said that there isn't anything that specifically addresses that but there is reference to adequate disposal of waste and nothing that addresses distance of houses to water stream only to the property lines.

Councilwoman Wasson commented that the houses on a half-acre in the Hamlet are much different than a half-acre in areas outside of the Hamlet with the density of the homes. In her experience she felt that having chickens next door to a house that is for sale is a detriment. Her other concern is the water streams and the waste going into the streams.

Supervisor Dobson questioned if a person has chickens in a smaller zoning district would they be grandfathered in if the Board decides to remove Section 43-22. The Building Inspector said that they would not be grandfathered in and would not be allowed to keep the chickens.

Councilman Shero said that in his experience in another town is that they allow 6 chickens on a lot regardless of size and there have been numerous issues such as rats and fox being attracted to houses with chickens in addition to the offensive odors from the chicken waste.

The consensus of the Board was to remove Section 43-22 and re-notice the public hearing for the October meeting.

Councilman Shero made a motion to table Local Law No. 2 of 2019, seconded by Councilwoman Wasson and unanimously carried.

#### Local Law No. 3

Local Law No. 3 of 2019- Chapter 130 Article III Supplemental Use and Dimensional Regulations. Revise Section §130-33 Minimum Required Open Space.

The Building Inspector commented that at the time of the solar law being adopted, it was found we didn't have open space provisions to provide to developers. This proposed law will satisfy that need.

There was a question on the parameters to require an open space plan. The Building Inspector responded that this law would give the Planning Board the ability to require an open space plan. The board consensus is that they would like to see parameters in the code detailing when an open space plan would be necessary.

There being no further comment Councilwoman Wasson made a motion to table Local Law No. 3 of 2019, seconded by Councilman Mullin and unanimously carried.

## Local Law No. 4

Local Law No. 4 of 2019, Chapter 54 BUILDING CONSTRUCTION AND FIRE PREVENTION. Addition of Sections §54-29 Fire Prevention, Fire Lanes.

The Building Inspector commented that we have never had this in place previously and the fire code mandates that the fire lanes are kept clear at all times. This establishes the lanes and enforcement.

There was discussion of the enforcement of violations regarding the fire lanes.

There being no further discussion, Councilman Mullin made a motion to table Local Law No. 4 of 2019, seconded by Councilman Shero and unanimously carried.

#### Local Law No. 5

Local Law No. 5 of 2019-Chapter 54 BUILDING CONSTRUCTION AND FIRE PREVENTION, Addition of Sections §54-28 Fire Prevention, Rapid Emergency Entry System.

There was discussion on the use of "Knox Box" Rapid Entry Key Box System and the importance of having them. The enforcement relating to the use and maintenance of current key to the Knox Box would be through the Fire Code at the time of the fire safety inspection.

There being no further discussion, a motion to table Local Law No. 5 of 2019 was made by Councilwoman Wasson made a motion to table Local Law No. 5 of 2019, seconded by Councilman Mullin and unanimously carried.

#### Local Law No. 6

Local Law No. 6 of 2019-Chapter 130 §130-75 Notice of Violations; penalties; remedies.

Attorney DiRaddo commented that the purpose of this local law is to decriminalize the violation to no more than 15 days in jail and \$1000/day for penalties for offenses regarding building construction and fire prevention, penalties for offenses for subdivision of land and violations of zoning.

There being no further discussion, a motion to table Local Law No. 6 of 2019 was made by Councilwoman Wasson, seconded by Councilman Mullin and unanimously carried.

#### Local Law No. 7

Local Law No. 7 of 2019-Chapter 130 §130-4 Definitions LOT WIDTH, ANIMAL HUSBANDRY

Attorney DiRaddo commented that this local law inserts the definitions from Local Law No. 2 into another section of the code.

There being no further discussion, a motion to table Local Law No. 7 of 2019 was made by Councilman Mullin, seconded by Councilwoman Wasson and unanimously carried.

Public Before the Board regarding the re- hearing on Local Law No. 2 of 2019-Chapter 43 ANIMALS Article II Regulation and Control of Animals. Additions of Sections 43-16, 43-17, 43-18, 43-19, 43-20, 43-21, 43-22, and 43-23.

Supervisor Dobson re-opened the public hearing at 6:03 P.M. and introduced Terry Rech, Building Inspector and Jay Coates, Planning Board Chairman.

Terry explained the different zoning districts within the town. He said that the majority of the town has the AR-2 designation with the lot size being a minimum of 2 acres and 200' of road frontage. A footnote in this zoning designation is that with public water and an approved septic system, a lot size of 50,000 sq. ft. and 175' road frontage is allowed. The majority of the rural activity is also in this district. Flood district is unique to Wheatland and has the designation of F-1 which mirrors the 100-year flood and the town is one of the only that has an F-1 and doesn't permit any construction. The smaller, denser residential districts (R districts) as well as some commercial districts are concentrated in the Mumford area. At the other end of town is the village and other small residential zoning districts where the lot sizes are much smaller in addition to the multi-family RA zoning district as well. Terry then went on to contrast the current code and the proposed code regarding Chapter 43. He commented that the proposed change was an attempt to allow for domestic chickens, more than they are currently allowed. The proposed code adds definition and clarity between commercial and private animal husbandry, it attempts to set reasonable lot size for farm animals similar to what exists but expands to the R districts on larger lots within these districts. He added that the majority of Wheatland is in the Monroe County Southwestern Ag District which would then allow for ag use and expansion of ag use, regardless of the zoning district that the town has implemented.

Supervisor Dobson said that there has been some misinformation circulating and hopes that with this public hearing, and by getting public comment and feedback there will be a clearer understanding of the proposed law. She said that Facebook is not recognized as an official means of communicating information to the Town. Comments or questions should be sent to the Town Clerk through email, the postal service or dropped off at the Town Clerk's office and that such

correspondence then becomes official. She summarized correspondence that had been received from the following individuals:

Tatianna Baker expressed her thoughts regarding chickens in the Hamlet of Mumford. She moved here recently and chose this area because of the ability to own chickens and livestock.

Brandy Warner is against passing the proposed local law and feels it is unfair. She lives near people that have had chickens and there has never been an issue. She said her property is on 8 acres and is in an R district. If she desires, she would like to be able to have chickens.

Tina Stevens said she does not have chickens but understands that once having chickens was strictly a farm activity is now something residents want in their backyards. She does understand the need for some regulation, in the Hamlet and Village but not outside of those areas. She said that she moved to Wheatland for the rural quality of life. She would like to see this issue tabled for further study.

Maureen Leupold lives here for the rural feel and would like to be able to maintain a small farmstead.

Councilwoman Wasson said that she has a concern with chickens in the Hamlet of Mumford. There are smaller lots sizes and three creeks. She has a concern with run off into the creek in addition to the impact on neighboring parcels with chickens. She said that it is more difficult for a person to sell their home if the neighbors' own chickens.

Jay Coates, Planning Board Chairman said that after many complaints and issues with farm animals, chickens, and roosters on small lots over the course of many years, the Planning Board was charged with reviewing the current code and making changes to address the issues. The Board researched existing codes from across the country and state in putting together the proposed code. He went on to explain the Planning Board's discussions regarding the proposed codes.

## **Public Before the Board:**

Michael Streb said that there seems to be a contradiction between sections 43-19 and 43-22 in regard to chickens in the R-24, R-16 and R-12 districts. He also questioned the number of chickens allowed in an AR-2 District.

Ryan Sherman asked for clarification of the numbers of chickens allowed currently and what is proposed. He said that he does have chickens and he takes care of them and has never had any complaints from surrounding properties. He said that the proposed code is very restrictive on the numbers of chickens allowed even on large parcels.

Cassandra Balonek commented that the information regarding the proposed local law was posted on Facebook to get the word out as it didn't seem that anyone was aware of the proposed local law being considered.

Colin Clement reiterated that the language and wording in the proposed document is inconsistent and unclear. He said he understands there may be a need for controls in dense residential areas but in areas with large parcels of many acres, he doesn't want to be over legislated.

Suzanne Stokoe said she was not aware of this proposed local law before today. She said she can understand in areas of Mumford or the Village, but to be so restrictive over the entire town, she feels is unreasonable. She said that there is a heritage of farming in Wheatland and its importance.

Mike Balonek said he understands there are some issues and suggested that maybe there should be an advisory board for people that are interested in having chickens. He talked about the importance of farming and encouraged anyone with questions to contact him.

Dominic Pellittere asked for clarification regarding his ability to have chickens on his property.

Lauren Krenzer said that it seems that a couple people have ruined it for everyone. She mentioned the heritage of farming in town that she would like to see remain.

Laura Michaels said that she and her husband own 24 acres on South Road and would like to have a hobby farm when they retire. She said that the proposed law would not allow for that to happen.
